

## **Exam Development**

NBCSN is proud to announce the results of the Job Task Analysis (JTA) survey conducted in 2023. The results of the JTA showed that the exam content outline (ECO) needed to be streamlined and clarified. The board has accepted the recommended changes from the Job Task Analysis Task Force.

The major changes to the ECO include reducing the number of exam domains from five (5) to four (4) and clarifying the number of exam questions per domain on the exam.

The exam content is not changing, but rather the organization of the exam content.

Health Problems and Nursing Management has been removed from the domain list, with the content being applied throughout the remaining four domains. The other four domain names have been updated to better reflect the area of practice.

#### **New Domains**

The new ECO will be used for the Summer 2025 (July-August 2025) exam administration and beyond.

A new Candidate Handbook will be released before the end of the year.

The NCSN Exam Review Book is currently being updated. However, the content in the current edition is still relevant to the current and future exams. The 2025 edition will be reorganized based on the new exam content outline.

## Recertification



### **Recertification News**

If your recertification is picked for audit, these are the most common reasons that your audit requires additional information in order to complete the recertification process:

The hours that you are claiming are not from a national accrediting agency such as ANCC, NASN, Boards of Nursing, etc.

You are claiming credit for 6 or more hours and not providing a syllabus or content outline.

The CEU certificate does not include your name. We often receive blank CEU certificates.

The CEU Certificate information does not match the CEU certificate that you uploaded.

You are claiming academic credit and there is no transcript included.

You are claiming credit for a course that is not accepted such as CPR and First Aid.

NBCSN strongly recommends you include MORE than the

75 credits required, should one or more of your courses/activities not meet the requirements.
